The State of Silicon Valley

Last year, the average annual individual earning in Silicon Valley was \$189K, and the median home price was \$1.8M. However, one-third of households operated below self-sufficiency standards, and one in four children lived below the poverty line.

The annual Silicon Valley Index tracks key indicators to assess the health and

wellness of Silicon Valley. It compares year-over-year population, housing, education, transportation, business, talent flow, and investment data to provide a diagnosis of the region.

The Top 25

Morgan Hill's 3rd quarter 2023 sales tax results showed 2% growth, while the Bay Area and California were down 3% and 1.6%, respectively. This quarter, the City's top 25 sales tax-producing businesses grew a collective 17%, and accounted for approximately 61% of all sales tax revenue generated into the General Fund.

Leveling the Playing Field for Access to Capital

Recognizing that access to capital is challenging for underinvested small businesses, especially those that are



diverse business-owned, California has set a goal to deliver 40,000 new small business loans over the next five years. The Technical Assistance for Capital Readiness program will provide loan process guidance, education of legal, accounting, and financial management skills, and bring awareness of statebacked capital programs.

California is allocating \$182M in grants to the Regional Investment Initiative to create thousands of jobs across the state's (13) economic regions. The initiative focuses on rapid family-supporting job growth in prime industries.

Commercial Property Tax Relief Is Underway

The number of Prop. 8 declines in value assessments in Santa Clara County in 2022 increased by more than 600% in 2023. An estimated 28% of the 17,000 decreased assessments were commercial properties. As a result, the Assessor's Office opened the informal Prop 8 review process four months early, starting February 16, 2024.
